REPORT FROM THE LEGISLATURE



Every November Canadians have the opportunity to remember all those who have served our nation and reflect upon the sacrifices they have made. As we observed Remembrance Day on November 11, we remembered and honour the sacrifices made by those who have served, and continue to serve, our country to defend our freedom.

Earlier this month, our government passed Bill 139, *The Saskatchewan Remembrance Observance Act* to ensure employees have the right to wear a poppy in the workplace. Protecting this right is a way to honour sacrifices made by veterans and their families.

Saskatchewan continues to receive good news on its strong and growing labour force. From October 2022 to October 2023, 19,300 jobs were added in the province. The unemployment rate fell to 4.4 per cent as of October 2023, the lowest among the provinces, and well below the national average of 5.7 per cent.

We also saw all-time highs for overall employment at 605,300 and female employment at 280,900. A growing labour force allows our province's economy to continue to grow, creating more opportunities and a better quality of life for everyone.

Our province's strong and growing economy allows our government to continue to invest in programs and services for Saskatchewan people. Our government is launching the new Saskatchewan Employment Incentive program to make life more affordable for working families with low incomes.

The new program will provide a financial benefit, supplementary health benefits, connections to employment, and housing supports. By helping parents to enter and stay in the workforce, this program will have lasting, positive impacts on the quality of life of Saskatchewan families.

We continue to invest in Saskatchewan's health care system to ensure everyone can get the care they need, when and where they need it. Work continues under the Health Human Resources Action Plan, our government's four-point plan to recruit, train, incentivize and retain health care workers, and we are seeing strong progress across several areas.

Forty-three Internationally Educated Nurses (IENs) from the Philippines have now arrived in Saskatchewan and are completing on-site clinical training. Upon completion of this training, they will be eligible for licensure and ready to begin work in our health care system before the end of December.

The 58 paramedic training bursaries announced in July were all awarded to support paramedic training for EMS providers. Due to the high rate of application uptake, our government has invested another \$290,000 to expand the program and award another 35 bursaries.

Our government also continues to invest in the protection of persons and property. The province's new Warrant Intelligence Team officially began operations on November 1, 2023. This team will work to suspend government benefits to prolific violent offenders with outstanding

warrants and share information to aid police in their apprehension.

We recently introduced important legislation to lay the foundation for the Saskatchewan Marshals Service, an independent, made-in-Saskatchewan police service. The Marshals will provide an additional law enforcement presence across Saskatchewan and support the RCMP, municipal and First Nations police when needed. Their duties will include responding to areas with high crime rates, combating gangs and illegal weapons, apprehending prolific offenders and individuals with outstanding arrest warrants, and investigating farming-related offenses like cattle theft and trespassing.

To protect landowners, our government has passed expanded legislation to ensure landowners who are owed compensation by companies drilling for oil or gas on their property can collect what they are owed. Amendments will give the Ministry of Energy and Resources and the Surface Rights Board of Arbitration more powers to protect landowners. These changes will enable the board and the ministry to enforce delinquent surface rights payments from oil and gas licensees and ensure landowners are properly compensated for property damage.

SASKATCHEWAN RECEIVED AWARD FROM CANADA-INDIA
BUSINESS COUNCIL



November 9, Premier Scott Moe accepted the Canada-India Business Council (C-IBC) Member of the Year Award in Toronto. The province of Saskatchewan was selected as this year's recipient for its long-standing relationship with the C-IBC and the strengthening of economic and social ties between Saskatchewan and India.

"Saskatchewan's relationship with the people of India has grown tremendously over the last 10 years. India is an extremely important partner for Saskatchewan, and we truly value the relationship we have built over the years," Moe said. "We are fortunate to have many opportunities for collaboration with India in agriculture, potash, uranium, education and more. I take pride in the mutual respect, shared knowledge, and hospitality we show each other and am looking forward to the success that we will continue to share in the years ahead."

For over 40 years, the C-IBC has been nurturing and developing relationships between the two jurisdictions to ensure growth and accelerate mutual prosperity. The Member of the Year Award is awarded to recognize the significant contributions made by a member who has been able to successfully build on this process. Saskatchewan shows continuous progress in strengthening the economies of Saskatchewan and India, which in turn creates jobs, opportunities and partnerships that will protect communities for generations to come.

"When you look at the things that India seeks and Canada offers, Saskatchewan rises to the top," C-IBC President and CEO Victor Thomas said. "The province has significantly strengthened its

ties the last several years, punctuated with a new office in India. This comes at a time when businesses and provinces, like Saskatchewan, are needed more than ever in this pivotal economic relationship."

India continues to be a major export market for Saskatchewan producers. In 2022, Saskatchewan exported \$1.4 billion of products to India, which is a 130.7 per cent increase from 2021. Saskatchewan's top export to India during this time was potash at \$966.5 million, which accounted for 69.3 per cent of Saskatchewan's total exports to India in 2022. Saskatchewan was also responsible for more than half of India's lentils imported in 2022.

Saskatchewan imported \$103.1 million of products from India which is 51.1 per cent higher than 2021. The top import was transmission or conveyor belts or belting of textile material at \$25.7 million which accounted for 24.9 per cent of the provinces' total imports from India.

While in Toronto this week, Moe and Trade and Export Development Minister Jeremy Harrison attended the Insights India Forum. This was an opportunity to meet with prominent Indian and Canadian businesspeople, government officials, academics, and members of the Indian diaspora on opportunities to build Saskatchewan-India trade and investment relations.

ESTABLISHING A PHYSICIAN ASSISTANT TRAINING PROGRAM IN SASKATCHEWAN




Saskatchewan will soon establish a Physician Assistant training program in the province!

They will be able to provide services in primary care, long-term care, emergency medicine, cancer care, general internal medicine, and surgical specialties.

CHANGES COMING TO GRADUATION CREDIT REQUIREMENTS

FOR 2024-25 SCHOOL YEAR



The Government of Saskatchewan is implementing changes to high school graduation requirements in Saskatchewan to provide students with more choice and flexibility in their education. These changes will be implemented in the 2024-25 school year and will affect students entering Grade 10 in September 2024:

- a new credit requirement at the high school level for a course that focuses on financial literacy;
- a change in the number of required credits for English language arts (ELA);
- a change in the number of required credits for social sciences; and





The changes are based on insight and recommendations received from the Saskatchewan Teachers' Federation; League of Educational Administrators, Directors and Superintendents; First Nation Education Authorities; post-secondary institutions; various Chambers of Commerce and parents. The feedback suggested that students require additional credit flexibility to learn subjects they are passionate about to help them successfully enter the workforce. These changes align Saskatchewan education standards to those across Canada.

"Allowing students more personal choice in their learning to better prepare them for their futures and getting Saskatchewan back to basics is a positive step forward," Education Minister Jeremy Cockrill said. "We have heard from the education sector that students need to be prepared for a rapidly changing labour market by focusing on the development of transferrable skills in areas such as financial literacy."

INVESTING IN PRIMARY CARE STABILIZATION



A one-time stabilization investment of \$20 million will be made to community-based fee-forservice family physicians in Saskatchewan.

This funding is a transitional measure that will build capacity for physicians to adopt a new madein-Saskatchewan family physician payment model based on blended capitation.

The stabilization funding will support family doctors who provide primary care services in clinic

settings that provide in-person patient visits and will support the delivery of essential health care services to patients in their communities.

SASKATCHEWAN IS INCREASING MINIMUM AGE FOR TOBACCO AND VAPOUR PRODUCT PURCHASE



the Government of Saskatchewan passed Bill 147 which amends *The Tobacco and Vapour Products Control Act* to increase the minimum age for tobacco and vapour product purchase from 18 years of age to 19.

The Government of Saskatchewan is committed to ensuring tobacco and vapour products are inaccessible to school-aged youth and that Saskatchewan youth are not targets of advertising for these products.

"Tobacco and vapour products should have no place in Saskatchewan schools," Health Minister Everett Hindley said. "That is why we are taking steps to protect students from being exposed to these products."

The change to legislation aligns age restrictions for smoking and vaping with existing restrictions on liquor and cannabis sales in Saskatchewan. Most provinces have harmonized the age

restrictions for the legal purchase of alcohol, cannabis, tobacco and vapour products in their jurisdiction.

Additional changes in the bill give greater clarity to existing restrictions on advertising and promotion of vapour products to youth.

"Vapour products are introducing Saskatchewan youth to the dangers of nicotine addiction," Hindley said. "We appreciate the efforts of youth groups and health partners advocating for extra protections in the province."

In developing this bill, the Ministry of Health consulted with external stakeholders, including tobacco and vapour product retailers, tobacco and vapour product manufacturers, health advocacy organizations, and First Nations and Métis groups.

The ministry also acknowledges the efforts of the Youth4Change group, who met with the Minister of Health and other MLAs earlier this year to advocate for changes that will protect youth from the harms of tobacco and vapour products.

The legislative changes will come into force at a later date.

SASKATCHEWAN RAISES SMALL CLAIMS LIMIT IN PROVINCIAL COURTS

Small Claims Court Increase



* Second highest in Canada, starting April 1, 2024



The Government of Saskatchewan has passed new regulations that increase the monetary limit for claims that can proceed through the Provincial (Small Claims) Court from \$30,000 to \$50,000. The Regulations, which formally take effect on April 1,2024, will make Saskatchewan's small claims limit the second-highest in Canada.

"Pursuing matters through Provincial Court provides a more user-friendly, cost-effective way to resolve matters, often without the need for a litigant to hire a lawyer," Justice Minister and Attorney General Bronwyn Eyre said. "Provincial Courts also operate in more communities across the province, so applicants have increased options for filing their claim, which reduces travel."

"This increase to \$50,000 in claimable damages will help more Saskatchewan people resolve certain civil disputes in a quick and cost-effective manner," The Canadian Bar Association, Saskatchewan Branch President Steven Dribnenki said. "This will help improve Access to

Justice."

WHAT IS THE OVERDOSE OUTREACH TEAM?



Regina and Saskatoon Overdose Outreach Teams (OOT) continue to help people reduce their risk of overdose and other drug-related harms. Teams include a counsellor from the Saskatchewan Health Authority (SHA) and a paramedic from Regina Fire Services or Saskatoon Fire Department.

OOTs unite those at risk with community supports. As one example, a person struggled with an opioid use disorder for several years. After having a dangerous overdose requiring life support, they openly spoke to their family and shared they wanted a change. Hospital staff then connected the family with OOT.

"OOT assisted the client and their family by connecting them with Mental Health and Addiction Services (MHAS) and community organizations that could support their needs," said Nicole Schumacher, SHA Director of MHAS. "This included referrals to detox and treatment, support to access medication, connections to income assistance services, and counselling."
